Puppy Guarantee and Bill of Sale

Grünberg Shepherds sold to the buyers (as signed below) one German shepherd dog for the full purchase price of _____. This sale is final and guarantees are not transferable. This is a purebred _____ whelped on _____.

_____AKC papers will be furnished at a later date.

This puppy is guaranteed against severe hip dysplasia up to one year of life. These are the conditions that must be met:

1. The dog must be x-rayed at the buyer's expense.
2. The dog must be properly positioned as described by Dr. Davis, DVM at Troy Animal Hospital in Ohio. The buyers agree to view the video The Importance of Precise Positioning for OFA Radiographs and adhere to its recommendations.
3. Females need to be x-rayed 6-8 weeks away from end of heat cycle.
4. Diet is extremely important for puppy's health. Grünberg cannot guarantee good hips and overall health if a dog is not fed the recommended raw, complete diets.

Here are the steps to take if your dog is suspected of having severe hip dysplasia:

1. Grünberg must be contacted immediately.
2. Grünberg reserves the right to examine the x-rays and have her own personal vet examine them.
3. If there is a disagreement between Grünberg and the buyers, then x-rays must be sent to the OFA, a neutral body.
4. If severe hip dysplasia is confirmed, AKC papers must be returned to Grünberg and the dog spayed or neutered.
5. The buyer is then entitled to a replacement puppy of equal value to be selected by Grünberg as soon as one becomes available.

We also guarantee our puppies against weak nerves or temperament. If such a claim is made, the animal must be returned to us for evaluation.

Please note that all disputes must be settled in Henderson County, the home of Grünberg.

The buyer also understands that in the event s/he is unable to provide a home for this pup at any time in the future, Grünberg must be notified and given first right of refusal.

The seller agrees to:

1. No strenuous exercise for pup under 18 months of age. This means no long runs, no thrown Kongs or balls or frisbees!!
2. No tying or staking out of dogs.
3. Take full responsibility for this puppy which includes proper training, socialization, and veterinary care.
4. Have already purchased the recommended raw food and will continue to feed the complete, raw diet.
5. Attach "Von Grünberg" as part of the pup's name and on any official documents.
